Corrigendum :-

Para 10(iii) of the Government Resolution under reference shall be read as “If the project is on cooperative basis to submit the information and prove that 80% of the total members of the cooperative society are belongs to Scheduled Castes or Tribes or Minority communities. (in case of Scheduled Castes/Tribes caste certificate issued by appropriate authority will be considered as a valid proof. Muslim, Christians, Sikhs, Buddhists, Zoroastrians (Parsis) and Jain communities residing in the State of Maharashtra as the minority communities. In case of minority community religion/caste written on the School Leaving Certificate of concern person, in case of Christians Baptisam Certificate and if any other proof is not available affidavit of the concern person will be considered as a valid proof.)”
